# INTRODUCTION

Columbus Metropolitan Housing Authority (hereinafter, "HA") is a public entity, formed in 1934 to provide federally subsidized housing and housing assistance to low-income families, in Columbus and Franklin County. CMHA is headed by a President & CEO and is governed by a Board of Commissioners and is subject to the requirements of Title 24 of the Code of Federal Regulations (hereinafter, "CFR") and CMHA's procurement policy. The Agency was brought into existence by resolution of the State of Ohio's Board of Housing on May 8<sup>th</sup>, 1934. CMHA is a subdivision of the State of Ohio.

Currently, the HA owns and/or manages: (a) 26 multi-family apartment complexes totaling 3,139 units; (b) eight senior complexes, totaling 733 units; and (c) four Service Enriched complexes, totaling 258 units. the HA also administers approximately 13,000 Section 8 Housing Choice Vouchers and manages the HUD Project Based Rental Assistance contracts covering 81,000 units in Ohio and Washington, D.C. through its subsidiary, Assisted Housing Services Corporation. The HA currently has approximately 156 employees.

n keeping with its mandate to provide efficient and effective services, the HA is now soliciting proposals from qualified, licensed and insured entities to provide the services specified herein to the HA. All proposals submitted in response to this solicitation must conform to all of the requirements and specifications outlined within this document and any designated attachments in its entirety.

# 1.0 HA'S RESERVATION OF RIGHTS:

- **1.1** The HA reserves the right to reject any or all proposals, to waive any informality in the RFP process, or to terminate the RFP process at any time, if deemed by the HA to be in its best interests.
- **1.2** The HA reserves the right not to award a contract pursuant to this RFP.
- **1.3** The HA reserves the right to terminate a contract awarded pursuant to this RFP, at any time for its convenience upon 30 days written notice to the successful proposer(s).
- **1.4** The HA reserves the right to determine the days, hours and locations that the successful proposer(s) shall provide the services called for in this RFP.
- **1.5** The HA reserves the right to retain all proposals submitted and not permit withdrawal for a period of 60 days subsequent to the deadline for receiving proposals without the written consent of the HA Contracting Officer (CO)/Purchasing Manager.
- **1.6** The HA reserves the right to negotiate the fees proposed by the proposer entity.
- **1.7** The HA reserves the right to reject and not consider any proposal that does not meet the requirements of this RFP, including but not necessarily limited to incomplete proposals and/or proposals offering alternate or non-requested services.
- **1.8** The HA shall have no obligation to compensate any proposer for any costs incurred in responding to this RFP.

**2.0 SCOPE OF WORK (SOW)/TECHNICAL SPECIFICATIONS (T/S):** Columbus Metropolitan Housing Authority (CMHA) seeks to procure a provider ("Provider") to administer the Violence Against Women Act (VAWA) program. CMHA is a Public Housing Authority that administers the US Department of Housing and Urban Development's (HUD) Public Housing and Housing Choice Voucher (HCV) programs in Franklin County, Ohio. Violence Against Women Act housing protections are available to CMHA residents experiencing domestic violence, sexual assault, dating violence, or stalking while participating in the aforementioned HUD programs. Upon certification of residents' eligibility under VAWA, claimants are issued a new Housing Choice Voucher (HCV) to expedite their safe relocation.

Provider responsibilities will include certifying VAWA claims, connecting claimants to appropriate supportive services, and coordinating with CMHA regarding voucher issuance. As CMHA receives requests for VAWA transfers, CMHA staff will conduct an initial screening to verify whether the claimant resides within CMHA's housing portfolio and, in turn, whether the individual is eligible for VAWA protections through CMHA. Regardless of the claimant's eligibility status, CMHA will refer the claimant to the provider to either begin the certification process or connect the individual to alternative resources that are appropriate to their individual situation and desired level of support.

For claimants who are eligible to pursue VAWA certification through CMHA, the Provider will prepare forms HUD-5382 and HUD-5383, create a VAWA file (must be kept separate from the claimant's Housing Choice Voucher file), and contact the claimant to schedule an appointment, during which the Provider will gather information needed to either certify or deny the resident's VAWA certification. Regardless of the resident's certification status, the Provider will offer to connect the resident to supportive services appropriate to their individual situation and desired level of support.

As the Provider processes certifications, they will notify the claimant to confirm the status of their VAWA certification and provide them with a copy of HUD-5380. The Provider will then initiate the voucher issuance process by sending CMHA an Emergency Transfer request. Once the resident receives their new HCV and can begin their housing search, the Provider will continue to support the resident by helping them locate and apply for a new housing unit. In the event the claimant approaches the Provider with questions regarding the voucher issuance process or their housing status, the Provider will refer such questions to CMHA. The Provider will be responsible for collecting Release of Information forms as applicable when providing documentation to and communicating with CMHA throughout the VAWA certification and voucher issuance process.

All claims received by the Provider will be added to a tracking spreadsheet shared with CMHA. Throughout the certification and voucher issuance process, the Provider will be expected to update the tracking spreadsheet accordingly and save all relevant documents in the claimant's VAWA file. The Provider will prepare required enrollment, activity, outcomes, and/or financial reports in formats and within deadlines specified by CMHA. Provider performance measures will be tracked and reported to CMHA on a monthly basis and will assess productivity, efficiency, and quality of service delivery for the VAWA program.

The provider must, at all times, refrain from engaging in inherently political or religious activities, such as religious worship, religious instruction, or proselytizing, as part of administering the VAWA program. Furthermore, the provider will not discriminate against any proposed applicants or participants based on race, national origin, ethnicity, religion, age, sexual orientation, gender, gender identity or expression, disability, color, ancestry, military or veteran status, familial status, genetic information or any other characteristic protected by federal, state or local law.

In addition to addressing the aforementioned services, providers must demonstrate in their response to this RFP that they meet the following criteria:

- Active member of the Ohio Domestic Violence Network,
- Provide clinical counseling and mental health services specifically for those impacted by domestic violence, sexual assault, and stalking,
- Provide community-based services including but not limited to medical, legal, and social supports,
- Partner with law enforcement and child protective services,
- Have experience serving diverse communities, including families and youth, using trauma-informed practices, and
- Have existing capacity to accept VAWA referrals from the over 14,000 households CMHA serves across Franklin County.

# I. Terms of Services

**Collaborative Responsibilities.** Throughout the project, the provider and CMHA (collectively, the "Parties") will work collaboratively to meet the objectives of the Scope of Work, which will include:

- Committing the necessary staff and resources to meet the expectations and perform the activities/services/programs outlined in the Scope of Work. The provider shall furnish all labor, material, permits, equipment, and services necessary to perform and complete all work outlined in the Scope of Work. Activities listed in the Service to be Rendered section of this Scope of Work constitute the "Program".
  - a. At all times, provider employees shall be considered, for all purposes, employees of the provider and not of CMHA. CMHA shall not have any authority to, on behalf of the provider or otherwise, discharge, promote, suspend, or otherwise discipline any provider employee. However, CMHA retains the right, at any time for any reason, to have any provider employee removed from the Program.
- 2. Using agreeable time commitments and goals; using an evaluation and measurement system; meeting to discuss progress; establishing agreeable milestones.
- 3. Identifying primary points of contact for the Program.
- 4. Maintaining consistent written and oral communication regarding all aspects of the Program.

- 5. Facilitating discussions and evaluations of mutual activities and the progress toward goals as needed.
- 6. Facilitating collaborative decision making, coordinated action, and information collection and dissemination among organizations participating in the Program.
- 7. Including CMHA in any media publications related to the Program.

**Independent Contractor Provisions.** The Provider will be considered an independent contractor of CMHA, and nothing contained herein shall be construed to form a legal partnership between the parties, nor to create any form of employment relationship or any other relationship which would impose liability upon one party for the act of the other party. Neither CMHA nor the Provider shall have any authority to commit, contract for or otherwise obligate the other to any third party. Additionally, each party shall secure all personnel required in the performance of its obligations as set forth in this Scope of Work. Each party shall also be solely responsible for any and all taxes, payments and reporting requirements associated with any such personnel used.

The Provider, as an independent contractor of CMHA, assumes all risk of personal injury, and all risk of damage to or loss of property belonging to CMHA and used in this Program, to the extent that such injury, damage, or loss is attributable to the acts or omissions of the Provider. The Provider agrees to indemnify and hold harmless CMHA, and each of its directors, officers, employees, and agents from and against any loss, cost, damage, expense, claim, and liability of every kind and description, including reasonable attorneys' fees, disbursements, and court costs, arising out of, resulting from, or related in any way to the provision of the services described in this Scope of Work.

**Confidentiality.** No party, nor its employees, agents, officers or directors, shall disclose any Confidential Information to any third party without prior written consent of the others. For purposes of this Scope of Work, "Confidential Information" includes proprietary and/or trade secret information as may be provided to, or learned by, any party or its employees, agents, officers or directors during the course of the Program that is not otherwise available to the general public. Confidential Information does not include any information that (a) becomes publicly available through no act of either party; or (b) is rightfully received by either party from a third party which is not subject to a confidentiality restriction (c) subject to disclosure under Ohio's Open Records laws.

**Taxes.** All tax and other returns required by city, local, state, or federal laws or regulations with respect to payments made to the provider by CMHA under any Purchase Orders executed in connection with this Scope of Work, and all payments or taxes due thereon, and all licenses, registrations, permits, and the like, and all fees or other payments or coverage required or due in connection therewith, including generally, but not limited to, tax withholdings, unemployment coverage, workers' compensation coverage, disability coverage, and other taxes, etc., shall be made, filed, paid, procured, and maintained by the provider.

**Insurance.** During the term of any Purchase Orders executed in accordance with this Scope of Work and the operation of the Program the Provider shall maintain commercial general liability insurance with a minimum of \$1,000,000 in coverage, such coverage should include Columbus Metropolitan Housing Authority as an additional insured, and the Provider must

provide proof of the foregoing to CMHA upon the execution of any Purchase Orders associated with this Scope of Work.

**Mediation.** The parties agree to make a good faith effort to resolve any and all differences arising among them in the interpretation or performance of activities contained in this Scope of Work. If the parties fail to reach agreement on any matter, then prior to taking legal action, the parties shall attempt to employ, at no cost, the services of a third person mutually acceptable to the parties to mediate the dispute within five (5) days of appointment. If a mutually acceptable mediator cannot be agreed upon, or mediation fails for any other reason, either party may elect to proceed to legal action.

**Negligent Acts or Omissions.** Each Party to any Purchase Orders executed in accordance with this Scope of Work shall be responsible for any liability, claim, loss, damage or expenses, including without limitation, reasonable attorney fees, arising from its own negligent acts or omissions in connection with its performance of this Agreement, or its failure to comply with the terms of any Purchase Orders executed in connection with this Scope of Work, as determined by a court of competent jurisdiction.

**Use of Name and Marks.** The Parties agree not to make any written use of or reference to the other Party's names, trade names, fictitious business names, trademarks, service marks, or logos for any marketing, public relations, advertising, display or other business purpose or make any use of the other Party's facilities for any activity unrelated to the express business purpose and interests under any Purchase Orders executed in accordance with this Scope of Work, without prior written consent.

## PROPOSAL FORMAT:

**3.1 Tabbed Proposal Submittal:** The HA intends to retain the successful proposer pursuant to a "Best Value" basis, not a "Low Proposal" basis ("Best Value," in that the HA will, as detailed within the following Section 4.0, consider factors other than just cost in making the award decision). Therefore, so that the HA can properly evaluate the offers received, all proposals submitted in response to this RFP must be formatted in accordance with the sequence noted following. - **3.3.1 Quantities:** All quantities entered by the HA herein are for calculating purposes only. As may be further detailed herein, the HA does not guarantee any minimum or maximum amount of work as a result of any award ensuing from this RFP, as the ensuing contract will be a Requirements Contract, in that the HA shall retain one contractor only and shall retain the right to order from that contractor (successful proposer), on a task order basis, any amount of services the HA requires.
- **3.4 Proposal Submission Hard Copy Method:** All pricing must be submitted via separate, sealed envelope and all "hard copy" proposals must be submitted and time-stamped received in the designated HA office by no later than the submittal deadline stated herein. A total of 1 original signature copy (marked "ORIGINAL") and 2 exact copies (each of the 3 separate proposal submittals shall have a cover and extending tabs) of the "hard copy" proposal submittal, shall be placed unfolded in one (1) sealed package and addressed to:

The package exterior must clearly denote the above noted RFP number and must have the proposer's name and return address. Proposals received after the published deadline will not be accepted.

## Only one submission is required, either via the electronic method or the hard copy method.

- **3.4.1 Submission Responsibilities:** It shall be the responsibility of each proposer to be aware of and to abide by all dates, times, conditions, requirements and specifications set forth within all applicable documents issued by the HA. By virtue of completing, signing and submitting the completed documents, the proposer is stating his/her agreement to comply with the all conditions and requirements set forth within those documents.
- **3.5 Proposer's Responsibilities--Contact With the HA:** It is the responsibility of the proposer to address all communication and correspondence pertaining to this RFP process to the CO or Purchasing Agent only. Proposers must not make inquiry or communicate with any other HA staff member or official (including members of the Board of Commissioners) pertaining to this RFP. Failure to abide by this requirement may be

cause for the HA to not consider a proposal submittal received from any proposer who may has not abided by this directive.

- **3.5.1** Addendums: All questions and requests for information must be addressed in writing to the CO or Purchasing Agent. The CO or Purchasing Agent will respond to all such inquiries in writing by addendum to all prospective proposers (i.e. firms or individuals that have obtained the RFP Documents). During the RFP solicitation process, the CO or Purchasing Agent will NOT conduct any *ex parte* (a substantive conversation—"substantive" meaning, when decisions pertaining to the RFP are made—between the HA and a prospective proposer when other prospective proposers are not present) conversations that may give one prospective proposer an advantage over other prospective proposers.
- **3.6 Pre-proposal Conference:** The scheduled pre-proposal conference identified on Page 2 of this document is, pursuant to HUD regulation, not mandatory. The purpose of this conference is to assist prospective proposers in having a full understanding of the RFP documents so that he/she feels confident in submitting an appropriate proposal; therefore, at this conference the HA will conduct an overview of the RFP documents, including the attachments. Prospective proposers may also ask questions, though the CO may require that some such questions are delivered in writing prior to a response.

## 4.2 Evaluation Method:

- **4.2.1 Initial Evaluation for Responsiveness:** Each proposal received will first be evaluated for responsiveness (e.g., meets the minimum of the published requirements). The HA reserves the right to reject any proposals deemed by the HA not minimally responsive (the HA will notify such firms in writing of any such rejection).
- **4.2.2 Evaluation Packet for Proposals Deemed Responsive:** Internally, an evaluation packet will be prepared for each evaluator, including the following documents:
  - **4.2.2.1** Proposal Tabulation Form;
  - **4.2.2.2** Written Narrative Justification Form for each proposer;
  - **4.2.2.3** Copy of all pertinent RFP documents.
- **4.2.3 Evaluation Committee:** The HA anticipates that it will select a minimum of a three-person committee to evaluate each of the responsive "hard copy" proposals submitted in response to this RFP.

- **4.2.4 Evaluation:** The CO will evaluate and award points pertaining to Evaluation Factors No. 1 (the "Objective" Factor). The appointed evaluation committee, independent of the CO or any other person at the HA, shall evaluate the responsive proposals submitted and award points pertaining to Evaluation Factors No. 2, 3, and 4 (the "Subjective" Factors).
  - **4.2.5 Potential "Competitive Range" or "Best and Finals" Negotiations:** The HA reserves the right to conduct a "Best and Finals" Negotiation, which may include oral interviews, with all firms deemed to be in the competitive range. Any firm deemed not to be in the competitive range shall be notified of such in writing by the HA in a timely manner as possible.
  - **4.2.6 Determination of Top-ranked Proposer:** Typically, the subjective points awarded by the evaluation committee will be combined with the objective points awarded by the CO to determine the final rankings.
    - **4.2.6.1 Ties:** In the case of a tie in points awarded, the award shall be decided as detailed within Section 6.12.C of HUD Procurement Handbook 7460.8 REV 2, by "drawing lots or other random means of selection."
  - **4.2.7** Award Recommendation: It is anticipated that the final rankings will be forwarded to the HA Board of Commissioners (BOC) at a regularly scheduled board meeting for approval. Contract price negotiations may, at the HA's option, be conducted prior to or after the BOC approval.
  - **4.2.8** Notice of Results of Evaluation: If an award is completed, all proposers will receive by e-mail an Award Notification. Such notice shall inform all proposers of:
    - **4.2.8.1** Which proposer received the award;
    - **4.2.8.2** Where each proposer placed in the process as a result of the evaluation of the proposals received.
    - **4.2.8.3** The cost or financial offers received from each proposer.

## 5.0 CONTRACT AWARD:

- **5.1 Contract Award Procedure:** If a contract is awarded pursuant to this RFP, the following detailed procedures will be followed:
  - **5.1.1** By completing, executing and submitting the Form of Proposal, Attachment A, the "proposer is thereby agreeing to abide by all terms and conditions pertaining to this RFP as issued by the HA, in hard copy.
- **5.2 Contract Conditions:** The following provisions are considered mandatory conditions of any contract award made by the HA pursuant to this RFP:
  - **5.2.1 Contract Form:** The HA is not obligated to contract on the successful proposer's form when a HA form is available, and by submitting a proposal

the successful proposer agrees to do so (please note that the HA reserves the right to amend this form as the HA deems necessary).

- **5.2.1.1** Please note that the HA has no legal right or ability to (and will not) at any time negotiate any clauses contained within ANY of the HUD forms included as a part of this RFP.
- **5.2.3 Unauthorized Sub-Contracting Prohibited:** The successful proposer shall not assign any right, nor delegate any duty for the work proposed pursuant to this RFP (including, but not limited to, selling or transferring the contract) without the prior written consent of the CO. Any purported assignment of interest or delegation of duty, without the prior written consent of the CO shall be void and may result in the cancellation of the contract with the HA, or may result in the full or partial forfeiture of funds paid to the successful proposer as a result of the proposed contract; either as determined by the CO.
- **5.3 Contract Period:** The HA anticipates that it will award a contract for the period of one (1) year, with (4) one year option not to exceed five (5) years.
- **5.4** Licensing and Insurance Requirements: The successful proposer will be required to provide:
  - **5.4.1** An original certificate evidencing the proposer's current industrial (worker's compensation) insurance carrier and coverage amount;
  - **5.4.2** An original certificate evidencing General Liability coverage, naming the HA as an additional insured, together with the appropriate endorsement to said policy reflecting the addition of the HA as an additional insured under said policy (minimum of \$1,000,000 each occurrence, general aggregate minimum limit of \$1,000,000, together with damage to premises and fire damage of \$50,000 and medical expenses any one person of \$5,000);
  - **5.4.3** An original certificate showing the proposer's professional liability and/or "errors and omissions" coverage (minimum of \$1,000,000 each occurrence, general aggregate minimum limit of \$1,000,000);
  - **5.4.4** An original certificate showing the proposer's automobile insurance coverage in a combined single limit of \$1,000,000. For every vehicle utilized during the term of this program, when not owned by the entity, each vehicle must have evidence of automobile insurance coverage with limits of no less than \$50,000/\$100,000 and medical pay of \$5,000;
  - **5.4.5** If applicable, a copy of the proposer's license issued by the State of Ohio licensing authority allowing the proposer to provide the services detailed herein.
  - **5.4.6** The requested related information shall also be entered where provided for on the Profile of Firm Form.
- **5.5 Right to Negotiate Final Fees:** The HA shall retain the right to negotiate the amount of fees that are paid to the successful proposer, meaning the fees proposed by the top-rated

proposer may, at the HA's options, be the basis for the beginning of negotiations. Such negotiations shall begin after the HA has chosen a top-rated proposer. If such negotiations are not, in the opinion of the CO successfully concluded within 5 business days, the HA shall retain the right to end such negotiations and begin negotiations with the next-rated proposer.

**5.6 Contract Service Standards:** It is the responsibility of the prospective proposer to ensure that all items and services proposed conform to all local, state and federal law concerning safety (OSHA) and environmental control (EPA and Franklin County Pollution Regulations) and any other enacted ordinance, code, law or regulation. The successful Proposer shall be responsible for all costs incurred for compliance with any such possible ordinance, code, law or regulation. At no time shall extensions be granted or financial consideration given to the successful Proposer for time or monies lost due to violations of any such ordinance, code, law or regulations that may occur.

## 6.0 ADDITIONAL CONSIDERATIONS:

- 6.1 Required Permits and Licenses: Unless otherwise stated in the RFP documents, all Federal, State or local permits and licenses which may be required to provide the services ensuing from any award of this RFP, whether or not they are known to either CMHA or the proposers at the time of the proposal submittal deadline or the award, shall be the sole responsibility of the successful Proposer and all offers submitted by the Proposer shall reflect all costs required by the successful Proposer to procure and provide such necessary permits or licenses.
- **6.2 Taxes:** All persons doing business with CMHA are hereby made aware that CMHA is exempt from paying Ohio State Sales and Use Taxes and Federal Exercise Taxes. A letter of Tax Exemption will be provided upon request.
- **6.3 Official, Agent and Employees of CMHA Not Personally Liable:** It is agreed by and between the parties hereto that in no event shall any official, officer, employee, or agent of CMHA in any way be personally liable or responsible for any covenant or agreement herein contained whether expressed or implied, nor for any statement, representation or warranty made herein or in any connection with this agreement.
- **6.4 Termination:** Any contract resulting from this RFP may be terminated under the following conditions:
  - 6.4.1 By mutual consent of both parties, and
  - **6.4.2 Termination For Cause:** As detailed within Clause No. 3 of Form HUD-5370-C (10/2006), *General Conditions for Non-Construction Contracts, Section I (Within or without Maintenance Work),* attached hereto:
    - **6.4.2.1** CMHA may terminate any and all contracts for default at any time in whole or in part, if the contractor fails to

perform any of the provisions of any contract, so fails to pursue the work as to endanger performance in accordance with the terms of the RFP or any resulting contracts, and after receipt of written notice from CMHA, fails to correct such failures within seven (7) days or such other period as CMHA may authorize or require.

- **6.4.2.1.1** Upon receipt of a notice of termination issued from CMHA, the Contractor shall immediately cease all activities under any contract resulting from this RFP, unless expressly directed otherwise by CMHA in the notice of termination.
- **6.4.2.1.2** CMHA may terminate any contract resulting from this RFP in whole or in part, if funding is reduced, or is not obtained and continued at levels sufficient to allow for the expenditure.
- **6.4.3 Termination For Convenience:** In the sole discretion of the HA, CMHA may terminate any and all contracts resulting from this RFP in whole or part upon thirty (30) days prior notice to the Contractor when it is determined to be in the best interest of the HA.
- **6.4.4** The rights and remedies of CMHA provided under this section are not exclusive and are in addition to any other rights and remedies provided by law or under any contract.

Proposers are to quote firm prices unless otherwise noted in the specifications. In case of a discrepancy in computing the amount of the proposal, the UNIT PRICE quoted will govern. In the event of a conflict between the price in numbers and the price in words, the price IN WORDS WILL CONTROL.

Quotations are requested F.O.B. destination. If quoted F.O.B. Shipping Point, include freight estimate and full value insurance cost.

## ACCEPTANCE AND REJECTION

This proposal will be accepted or rejected within a period of sixty (60) days from the proposal opening date. CMHA reserves the right to reject any and all proposals, to waive technicalities, and to request a re-quote on the required materials and/or services. If more than one item is listed, prices shall be quoted on each unit. However, each item shall be considered a separate proposal and CMHA reserves the right to award a contract on each item separately proposed, or on all items as a whole or any combination thereof. Proposers whose proposal is made on an "all or none" basis must clearly state such fact in the proposal.

## WITHDRAWAL OF PROPOSALS

Proposers may withdraw their proposals at any time prior to the time specified in the advertisement as the closing time for the receipt of proposals. However, no Proposer shall withdraw or cancel his proposal for a period of sixty (60) days after said advertised closing time for the receipt of proposals.

# SUBMISSION OF PROPOSAL

Proposals must be submitted on the attached proposal page unless otherwise noted in the specifications. Blank spaces in the proposal must be completed and the phraseology is not to be changed. Any additional conditions, limitations, or provisions attached to the proposal may result in its rejection. It is important that all pages be in proper sequence. If the vendor does not wish to propose, the proposal should be so marked.

Proposals received prior to the time of the opening will be securely kept, unopened. No proposal received after the specified time will be considered except under the following conditions: if a proposal arrives by mail after the time fixed for opening, but before award is made, and it is shown to the satisfaction of the awarding officer that late arrival was due solely to delay in the mails, such proposals will be received and considered. No responsibility will attach to an officer for the premature opening of a proposal not properly addressed and identified.

Proposals must be submitted in a sealed envelope and clearly state the Proposer's Name, Address, RFP number and RFP Submittal deadline date.

# CHANGES AND ADDENDA TO PROPOSAL DOCUMENTS

Each change or addendum issued in relation to this proposal document will be on file in the office of the Purchasing Department no less than five (5) working days prior to the scheduled proposal closing. In addition, to the extent possible, copies will be mailed to each person registered as having received a set of proposal documents. Total proposal or specific item cancellations may be issued later than the time specified above.

## **DELIVERY**

Time will be of the essence for any orders placed as a result of this proposal. Purchaser reserves the right to cancel such orders, or any part thereof, without obligation if delivery is not made within the time(s) specified. Delivery shall be made 8:00 a.m. to 4:00 p.m. Monday through Friday to the destination shown on the proposal.

## <u>QUALITY</u>

Unless otherwise stated by the proposer the proposal will be considered as being in strict accordance with the specifications outlined in the Proposal Document.

Reference to a particular trade, manufacturer's catalog or model number is made for descriptive purposes to guide the proposer in interpreting the requirements of CMHA. They should not be construed as excluding proposals on other types of materials, equipment and supplies.

However, the proposer, if awarded a contract, will be required to furnish the particular item referred to in the specifications or description unless a departure or substitution is clearly noted and described in the proposal.

# SAMPLES

Samples, when requested, must be furnished free of expense and, if not destroyed, will upon request be returned at the proposer's expense.

# INELIGIBLE PROPOSERS

CMHA is prohibited from making any awards to contractors, subcontractors or firms who are on lists of those ineligible to receive awards from the United States, as furnished periodically by HUD. The current list of ineligible firms is available for inspection by prospective proposers at the offices of CMHA.

CMHA is required to procure contracts only with responsible contractors, i.e. those who have the technical and financial competence to perform and who have a satisfactory record of integrity. Before awarding a contract CMHA will review the proposed contractor's ability to perform the contract successfully, considering factors such as the contractor's integrity, record of past performance, and financial and technical resources.

# AWARD OF CONTRACT

The contract will be awarded to the responsible proposer submitting the lowest proposal complying with the conditions of the Invitation for Proposal with equal consideration being given to the detailed action plan, provided his proposal is reasonable and it is to the interest of CMHA to accept it. CMHA will consider proof of success of procedures (i.e., references) in the final determination.

All specifications and proposal documents become a binding part of the contract.

# PERFORMANCE BOND

All proposers will be required to furnish a performance bond for any service/construction proposals requested by the HA. The performance bond of 100% of the full amount of the contract, which secures the faithful performance of the contract, must be furnished within 14 days of contract award. <u>No exceptions will be granted without prior written permission of CMHA</u>. Failure of the successful proposer to comply shall constitute a default. CMHA may either award the contract to the next reasonable proposer or re-advertise for proposals; and CMHA may charge against the proposer the difference between the amount of the proposal and the amount for which the contract for the work is subsequently executed.

# SUBCONTRACTORS

The contractor shall not contract with any proposed subcontractor who has not been accepted by CMHA. The contractor shall notify CMHA in writing the name of each proposed

subcontractor. The acceptance or any objection shall be expressed in writing by CMHA within ten (10) working days after receipt of said request. CMHA may, without claim for extra cost by the contractor, disapprove any subcontractor for cause on the basis of its own determination or, because the contractor is listed as ineligible to receive awards of contracts for the United States on a current list or lists furnished by HUD.

# **CANCELLATION**

CMHA reserves the right to monitor and evaluate the performance of a vendor, pursuant to this proposal, on a regular basis. Either CMHA or the vendor may terminate this contract upon a material violation of the terms herein, provided that the offended party issues written notice of the violation to the offending party.

# PRE-PROPOSAL CONFERENCE

Where advisable or in the Authority's interest a Pre-Proposal Conference will be conducted for all proposers as specified in the proposal advertisement (time and location). However, in lieu of the aforementioned, any proposer or prospective proposer interested in a pre-proposal conference may request one by contacting the Purchasing Agent within seven (7) days after the date of the first publication of the notice to proposal. This conference shall be for clarification of procedures and requirements connected with the preparation of responsive proposals only.

# MINORITY AND FEMALE BUSINESS ENTERPRISE POLICY

As policy, the HA will aggressively seek to contract with minority and/or female business enterprises for at least twenty percent (20%) of its annual dollar expenditures for construction, development and supply of goods and services. Initially, CMHA will seek to meet this goal by expanding and improving its contacts with appropriate minority and/or female business enterprises, so that more responsive proposals and competitive quotations can be solicited and received from such business enterprises. CMHA will, therefore, compile and maintain a master list of minority and female business enterprises (categorized and referenced by types of businesses) and related non-profit or service organizations. These businesses and specific groups will be kept informed, through outreach activities, regarding general and specific business opportunities with CMHA. Formal bidding through public advertisements will also be paid for or sponsored by CMHA with minority press and media as well as the major Columbus newspaper. Training sessions, focusing on both CMHA's general business practices and specific construction jobs or purchasing transactions, will also be conducted for the benefit of minority and/or female business enterprises on a regular basis. Actual contract awards for construction and purchasing will be recorded and monitored for minority and/or female business enterprise participation, and selected proposers will be expected to achieve their minority and/or female business enterprise commitments. Implementation duties for this policy will be delegated to the Minority Business/Contract Compliance Officer (for development activities) and the Purchasing Agent (for procurement activities), under the general supervision of the President\CEO.
